### **KINDLY READ THE STATUTE OF THE FEDERATION OF ESTATE AGENTS AND**

#### **NOTE THE FOLLOWING:**

#### **EXTRACT FROM THE STATUTE OF THE CHAMBER OF COMMERCE**

##### **ADMISSION**

**RULE 16** The Council has the right to admit as Associate Members the following:-

- 1(a) Junior Executives or co-owners of Firms (up to the age limit of 30 years) who are proposed by full members of the Chamber belonging to the same Firm;
- 2(b) Persons living outside Malta who are engaged in trading, commercial and industrial activity;
- 3(c) Persons who do not possess the qualifications for admission to the Chamber as defined in Rule 3 which states that 'all persons, no being public officers, engaged in trading, commercial and industrial activity in Malta, are eligible for membership'.

##### **NON-ELIGIBILITY**

**RULE 18** The Rules governing the admission of members shall apply in the case of admission of Associate Members provided that the decision of the Councils shall be final and rejected applicants may not appeal from the decision of the Council. Rule 14 regarding Non-Eligibility states that the following shall not be eligible to become members of the Chamber or of any Section or Sub-Section thereof:-

- 1(a) Undischarged bankrupts and interdicted persons;
- 2(b) Persons who suspend payments or compound with their creditors;
- 3(c) Persons who have been convicted by the Criminal Court for grave offences.
